Background:

- 1. UK8020 CIC UK 8020 CIC is a 'Not for Profit' Community Interest Company and is registered at Companies House in England and Wales, Registration no. 5627222
- 2. Registered Office: UK 8020 CIC, Elcombe House, 15 Elcombe Close, Bracklesham Bay, Chichester, PO20 8QZ, England
- 3. The Climate Change Challenge (also hereinafter referred to as "C3") is open to anyone and the challenge is to inventors to design a devise which will generate renewable energy and thus reduce the cost of supplying that energy to a home.
- **4.** Entrant/s are individuals or groups who have applied and are taking part in the Climate Change Challenge.
- 5. The Climate Change Challenge Rules & Conditions consist of a sequence of seven statements numbered from 1 to 7 culminating on point 7.2

1. Entry Requirements
